

EXTRACURRICULAR ACTIVITY CONTRACT

I realize that it is a privilege to participate in extracurricular activities at Banks Senior High School. Accordingly, I hereby agree to obey the following regulations and guidelines. **AS A MEMBER OF AN EXTRACURRICULAR TEAM THE STUDENT IS HELD TO THIS CONTRACT THE ENTIRE SCHOOL YEAR, INCLUDING THE FIRST TWO WEEKS OF DAILY DOUBLE IN AUGUST.** This contract is written in compliance with the Oregon School Activities Association, COWAPA League, and National Federation guidelines.

General Guidelines:

- 1a. In order to be eligible to participate in extracurricular activities at Banks High School, I realize that I must be enrolled in five classes and passing those five classes. I will make an effort to attain better than minimum grades.
- b. I realize that if my scholarship, sportsmanship, citizenship, and attendance record is reported unsatisfactory, I may become ineligible to participate until it is cleared through school or team policies.
- c. I must be present in school all day or have a pre-excused absence to participate in an activity for that day. Students absent for illness are not to participate on the day of an illness.
- d. To be eligible to participate in extracurricular activities, I am willing to take and pass a physical examination and to be covered by accident and health insurance. **I understand evidence of a physical must be on file before I may begin practice.**
- e. **Participation fees must be paid prior to 1st practice.**
2. I will conduct myself in an orderly manner, both on and off the campus, in such a way to bring credit to my school, my family, my community, and myself. School discipline will be evoked if necessary and team punishment for violations in this manner. **IE (Vandalism, Theft, or other crimes)**
3. Recognizing that extracurricular participation requires extra work on the part of the teachers who excuse me from their class periods to make trips away from campus, I will make arrangements to get my assignments in advance.
4. When provided, I will ride to and from the activity in school transportation and I understand I may only be released to my parents.
5. I will be personally responsible for all school equipment checked out to me and will return same in good condition when called for by the Coach/Advisor.
6. I will dress as per the dress code as stated in the student handbook and comply with any special guidelines by my coach.
7. I will report all injuries or accidents to my coach/advisor immediately.
8. I realize that Banks High School will offer a free Baseline Concussion Test by Impact Systems to all student-athletes at the beginning of their season.
9. I will treat the locker room area in a responsible manner, taking care to treat things placed there for my use as if they were my own, and I am financially responsible for their misuse.

Athletic/Activity Behavioral Standards

Participants in athletic/activity programs will adhere to all behavioral standards at all times.

Representing a school as part of an athletic/activity program is a **privilege**, and with the extra returns go certain responsibilities. The goal of behavior and conduct standards is two-fold:

1. Participants in athletic/activity programs shall present and conduct themselves in a manner which will bring credit to themselves, the student group or team they represent, or their school.
2. All athletic/activity participants will strive continually to improve themselves by attaining standards higher than those asked of the general student.

In order to attain these goals, the following standards will be in effect for all students who represent their school as participants in athletics/activities.

DEFINITIONS AND STANDARDS

1. An athlete is defined as a student who is a member of a team, ninth through twelfth grade. Athletic training standards require that athletes agree not to possess, use, sell, or provide alcohol, tobacco, or illegal/unauthorized drugs or related paraphernalia at any time.
2. Activity participants are defined as participants in school-sponsored groups, which represent the school publicly, or in competition with other schools. Activity participants will not possess, use, sell, or provide alcohol, tobacco, or illegal/unauthorized drugs or related paraphernalia at any time.
3. When a student is found consciously remaining in association with people possessing or using illegal chemicals, consequences may be levied under the athletic drug and alcohol policy.

PENALTIES:

In case of alleged violations, due process in the form of notification of alleged violation and the right to a hearing must be extended to students involved. The implementation of this policy rest with the building administration and high school athletic director. Consequences begin as soon as a building-level decision is made. Requests to appeal this policy shall be directed to the building principal.

FIRST OFFENSE: Participants in athletic/activity programs who violate drug, alcohol, or tobacco standards shall be suspended from participation and lose the right to represent the school for 20% of the team's contests. The athlete may participate in practice sessions but will not be allowed to participate in any contests that occur with this period. The athlete will not be allowed to participate in 20% of the contests and will be suspended from the first available and consecutive contests that occur during the athlete's next extracurricular activity should the violation occur at the end of the prior season. If the participants is suspended at the start of a contest they are ineligible for the entire contest.

As a condition of reinstatement and before representing the school in any activity thereafter, students who violate drug, alcohol, or tobacco standards will do the following: **If you choose not to do the following you will not be reinstated.**

- a. Have a drug/alcohol assessment to be paid for by the parent(s)/guardian(s). The family must have an appointment prior to returning to school.
- b. Sign a release allowing the assessor and the school administration to exchange information regarding student behavior and the assessment needs to be shared with school administration once the report is received. **THIS RESPONSIBILITY SOLELY LIES WITH THE STUDENT-ATHLETE.** Failure to do so will result in the loss of the ability to appeal the suspension.
- c. Work in cooperation with the school to follow through with the recommendations of the assessment.
- d. Enroll the student in a six session educational class on substance use and abuse to be provided by the student's parent(s)/guardian(s).

- e. Upon completion of the above procedure and satisfying the 20% contest suspension the student will be reinstated.

SECOND OFFENSE: Participants in athletic/activity programs who commit a second offense shall lose participation privileges for one (1) calendar year. Upon completion of the above procedure, the student will be reinstated after one calendar year.

THIRD OFFENSE: Athletic/Activity opportunities at Banks High School will be forfeited for the remainder of the student’s attendance at Banks High School.

If a student quits the team or chooses not to adhere to the punishment, then that student will have the consequences carried into their next season of participation. If the violation occurs at the end of one season it will carry over for the same time frame into the students next sport of participation.

THIS POLCIY WILL BE ENFORCED AS WRITTEN BY ALL ATHLETIC/ACTIVITY PROGRAMS AFFILIATED WITH BANKS HIGH SCHOOL. NO COACH OR ADVISOR MAY WEAKEN THE CONSEQUENCES NOR MAKE THESE CONSEQUENCES MORE SEVERE.
