Value added services included in the proposal will be considered for award of contract. All value-added services must be declared in detail by the Proposer, in writing, at the time of submittal of the formal proposal.

CONTRACT PERIOD

The equipment and services will be purchased only with a favorable ERATE approval of the items and services described in this RFP.

SCOPE OF WORK

A project drawing is attached, detailing specifications to assist in determining and verifying the quantities needed for a complete and properly installed system.

- Provide and install fiber optic network backbone cabling in the following quantities and areas: 12-strand single mode fiber cables from the Middle School MDF (Marked with "1" on Map") to each of the (3) MDF/IDFs as shown in the bid drawings. These locations are
 - Wrestling Building IDF (Marked with green "2"" on Map)
 - Modular Building IDF (Marked with "3" on Map)
 - Staff Lounge MDF (Marked with "4" on Map")
- Provide and Install 24" H x 24" W x 30" D Wall Mount Rack Enclosure Cabinet in Wrestling Building IDF.
- Provide and Install 36" H x 24" W x 30" D Rack Enclosure Wall Mount Cabinet with rack mount in new Staff Lounge MDF.

- Provide and install components to protect and organize cables such as Junction boxes, and conduits.
- Terminate fiber cables in rack mounted fiber distribution units or exterior enclosures as required with LC connectors in each of the listed locations.
- Test, label, and provide warranty for new fiber backbone cabling.
- Provide sufficient patch cords for patching in one half of the installed fiber strands.
