Student Retention Procedures

If school staff or parents have concerns about a student's educational progress in which retention appears to be an appropriate intervention, the following procedures will be followed:

- 1. Teacher to begin communication of concerns with parents prior to February 15th of the school year.
- 2. Parents may initiate retention requests, but need also to submit requests prior to February 15th of the school year.
- 3. Teacher will use the data team process to evaluate progress, determine obstacles to success and develop a plan to intervene.
- 4. On or about February 15th the teacher, parents and principal will convene a meeting to discuss:
 - a) Progress and interventions attempted
 - b) Parental concerns
 - c) District retention policy
 - d) Other assessments and/or data that may need to be collected to make a retention decision.
 - e) Identify whether concerns may be better addressed through a special education referral.
- 5. A final decision regarding retention will be made in time for annual student classroom placements.
- 6. When practical, a retained student will be placed with the current teacher for the next school year.
- 7. If the principal recommends placement in the next grade and the parent does not agree, the parent signs a Memorandum of intent that is placed in the student file to document that the retention decision was made by the parent and not the school team.
